Notes from the meeting

Comments from Jennie had been sent in prior to the meeting by email, and had been included in the draft of the Secondary section of the syllabus that was worked on by the working group.

Peter Ward had also submitted some amendments, which were worked through by the working group during the session.

The changes primarily related to:

- Correct terminology within the Humanism units and in the thematic worldviews units, including some additional suggestions for learning & clarifying humanist beliefs such as the lack of a 'soul'.
- Jennie has also agreed to produce some support materials for the Humanism units that will point teachers to good resources from Humanists UK
- Peter's comments related to the content of the Christianity units being reflective of the breadth of Christianity, not just the Church of England. The group felt that this was a very valid point, and that by law, the syllabus cannot be biased towards one denomination.
- Titles of some Christianity units were tweaked accordingly
- The order in which the Christianity units could be taught was also changed, as it was felt that the unit about humankind being fallen was too challenging for the start of Y7 and would fit better at the start of Y8.

All the changes can be seen in the revised version of the syllabus. The documents relating to the amendments have been archived with papers for this meeting.
